Unfortunately, the economic shock and unemployment backlash that Colorado is experiencing is creating a situation where many more people are requiring guidance and assistance, in conjunction with food and clothing, case management, and homeless prevention from Inter-Faith Community Services. Because of your generosity, Inter-Faith is able to meet the increasing demand for our services, as well as meet the new challenges that stem from this economic crisis.

Inter-Faith provides a “hand-up,” not a “hand-out” by giving motivation, incentive, and by providing services to low-income people in western and unincorporated Arapahoe and northern Douglas Counties. Inter-Faith reaches out to families through basic services, moral support, and educational programs and is always responsive and provides those in need with opportunities to learn, to grow, and to become or continue to be active and productive members of our community.

Your support made it possible for Inter-Faith to assist more than 20,000 individuals with homeless and hunger prevention services, clothing, and other financial assistance services. Programs and Services that Help in Many Ways

As the south metro area's stalwart provider of relief services, IFCS assists qualifying individuals, families and senior citizens through our programs and services.

- » Food and Clothing Banks provide no-cost clothing and no-cost meals for individuals and families
- » Emergency Financial Assistance provides rent, mortgage and utilities assistance
- » Transitional Housing: these two-year programs are designed to give homeless families an opportunity to grow, learn, and develop the ability to maintain self-sufficient lives by providing intensive case management, rent subsidy and support services
- » Gift of Sight and Hearing Programs for those in need of low- or no-cost hearing aids and/or glasses
- » Thanksgiving, Holiday Gift and Food Baskets for low-income families and seniors
- » Adopt-a-Family Program provides holiday gifts and necessities for qualified families and seniors
- » Birth Certificate program helps individuals secure public records at no cost to help them qualify for jobs, identification, benefits, etc.
- » Medical Prescription Assistance helps uninsured clients access prescriptions
- » Crime Victim's Assistance Program provides support and resources for crime victims
- » Recreation Passes for clients to access community recreational programs
- » The Sargent Fund helps low-income clients, whose needs fall outside of other grants, paying for special medical equipment, car repairs, etc.
- » Transportation Assistance provides bus tokens and gas certificates to help clients access benefits and seek employment
- » Case Management and Follow-up for clients in IFCS programs
- » Referral program helps clients access other community services
- » Lunch Bunch provides companionship and healthful meals for seniors
- » Grocery shopping assistance for homebound seniors
- » Ready, Set, School! Program provides school supplies and clothing to children each fall
- » Food for Learning Program supplements the payment for children on federal reduced lunch program
- » Career Center provides employment tools so that clients can achieve their employment and career goals

Report of Service

The 2009-10 year was very busy for Inter-Faith Community Services with many new clients and a large amount of services going to our community.

Financial Assistance

- » \$245,809 was spent to assist 881 individuals to prevent homelessness
- » \$9,443 was spent to assist 1,214 individuals with prescriptions, transportation, birth certificates, hearing aids, and Sargent Fund
- » \$49,874 was spent to assist 384 individual victims of crime

Basic Needs

- » 7,849 individuals received 117,735 meals. Each individual received enough food for three meals for five days. An estimated dollar amount of \$706,410 (\$18 per individual per day).
- » 2,047 individuals received clothing from the clothing bank. The estimate cost was \$81,880 (\$40 per individual)

Youth Services

- » 667 children received new clothes and school supplies through IFCS Ready, Set, School! Program
- » 324 children received backpacks and school supplies
- » \$11,824 was spent to provide 29,560 school lunches to low-income children through the Food for Learning Program

Senior Services

- » 6 seniors received services from IFCS Lunch Bunch and Grocery Shopping programs
- » 100 seniors benefited from IFCS' Holiday Programs — 200 food and gift baskets were distributed for Thanksgiving and Christmas

Other Services

- » 805 individuals received recreation passes from South Suburban and Englewood Recreation distributed at IFCS
- » 45 clients accessed the IFCS Career Center
- » 16 individuals received eyeglasses through IFCS Gift of Sight program
- » 2,523 individuals benefited from IFCS' Holiday Programs — 1,218 food and gift baskets were distributed for Thanksgiving and Christmas

New Clients

- » 788 new low-income individuals, families and senior citizens came to IFCS for assistance

Referrals

- » 9,048 referrals were made to other organizations

Volunteers

- » 8,346 volunteers gave 26,037 volunteer hours to IFCS
- » 16,861 low-income individuals were served during fiscal year 2009-2010

client story

Recently a woman came in for an appointment to get help with her mortgage. When speaking with our case manager she revealed that she had given birth 10 hours prior to this appointment. The case manager offered to re-schedule for another time. The woman said no, she was here and wanted to continue. After reviewing her budget and seeing that after this assistance she and her family would be back on their feet, funds were committed to pay her mortgage. She then returned to the hospital and her newborn son.
