## Programs and Services that Help in Many Ways

As the south metro area's stalwart provider of relief services, IFCS assists qualifying individuals, families and senior citizens through our programs and services.

### HUNGER PREVENTION PROGRAM

- » Food bank provides no-cost meals for individuals and families

### HOMELESS PREVENTION PROGRAM

- » Rent, mortgage and utilities assistance
- » Transitional Housing the two-year programs are designed to give homeless families an opportunity to grow, learn, and develop the ability to maintain self-sufficient lives by providing intensive case management, rent subsidy and support services

### FINANCIAL ASSISTANCE PROGRAMS

- » Birth Certificate program helps individuals secure public records at no cost to help them qualify for jobs, identification, benefits, etc.
- » Medical Prescription Assistance helps uninsured clients access prescriptions
- » Crime Victim's Assistance Program provides support and resources for crime victims
- » Transportation Assistance provides bus tokens and gas certificates to help clients access benefits and seek employment
- » The Sargent Fund helps low-income clients, whose needs fall outside of other grants, paying for special medical equipment, car repairs, etc.
- » Gift of Hearing Program provides those in need of low- or no-cost hearing aids

### ENRICHMENT PROGRAMS

- » Ready, Set, School! Program provides school supplies and clothing to children each fall
- » Holiday Programs provide holiday gift and food baskets for low-income families and seniors

### SENIOR PROGRAMS

- » Lunch Bunch provides companionship and healthful meals for seniors
- » Grocery shopping assistance for homebound seniors
- » Transportation to medical appointments for seniors

### OTHER ASSISTANCE

- » Clothing Banks provides no-cost clothing
- » Recreation Passes for clients to access community recreational programs
- » Gift of Sight provides low- to no- cost glasses
- » Career Center provides employment tools so that clients can achieve their employment and career goals
- » Case Management and Follow-up for clients in IFCS programs
- » Referral program helps clients access other community services

# Report of Service

The 2013-14 year was very busy for Inter-Faith Community Services with many new clients and a large amount of services going to our community.

## 15,448 low-income individuals were served during fiscal year 2013-2014

### NEW CLIENTS

- » 623 new low-income families, individuals, and senior citizens came to IFCS for assistance

### HOMELESS PREVENTION

- » \$142,818 was spent to assist 550 individuals to prevent homelessness

### HUNGER PREVENTION

- » 5,552 individuals received 116,592 meals. Each individual received enough food for three meals for five days. An estimated dollar amount of \$777,820.

### FINANCIAL ASSISTANCE

- » \$10,483 was spent to assist 780 individuals with medical prescriptions, transportation, birth certificates, hearing aids, and Sargent Fund
- » \$68,426 was spent to assist 289 crime victim individuals

### ENRICHMENT PROGRAMS

- » 531 children received new clothes and school supplies through IFCS Ready, Set, School! Program
- » 405 children received backpacks and school supplies
- » 4,077 individuals benefited from IFCS' Holiday Programs
- » 285 children received toys through IFCS' Holiday Program

### SENIOR PROGRAMS

- » 47 seniors participated in Lunch Bunch, Grocery Shopping and Medical Transportation programs
- » 103 seniors received food and gifts for Thanksgiving and Christmas

### OTHER ASSISTANCE

- » 1,686 individuals received clothing, totaling \$58,440
- » 1,108 individuals benefited from receiving recreation passes from South Suburban and Englewood Recreation, distributed through IFCS
- » 16 individuals accessed the IFCS' Career Center
- » 19 individuals received eyeglasses through IFCS' Gift of Sight program
- » 5,959 referrals were made to other organizations

### VOLUNTEERS

- » 2,037 volunteers gave 9,796 volunteer hours to IFCS
