IFCS also has two Transitional Housing Programs, designed to move families from homelessness to permanent, affordable housing. Provides assistance with bus tokens, gas vouchers, medical prescriptions and birth certificates. Operates the largest food bank in the South Metro Denver area. Additionally, through our enrichment Holiday Programs, eligible families and seniors are provided with the makings of Thanksgiving and Christmas meals.

Enrichment Programs: Ready, Set, School! provides children from low-income families in grades K-8 with necessary school supplies, including a backpack, new clothing, and gift certificates (shoes and haircut) for the beginning of the school year.
