## Programs and Services that Help in Many Ways

As the south metro area's stalwart provider of relief services, IFCS assists qualifying individuals, families and senior citizens through our programs and services.

### HUNGER PREVENTION PROGRAM

- » Food bank provides no-cost meals for individuals and families

### HOMELESS PREVENTION PROGRAM

- » Rent, mortgage and utilities assistance
- » Rapid Re-Housing are two-year programs are designed to give homeless families an opportunity to grow, learn, and develop the ability to maintain self-sufficient lives by providing intensive case management, rent subsidy and support services

### FINANCIAL ASSISTANCE PROGRAMS

- » Birth Certificate program helps individuals secure public records at no cost to help them qualify for jobs, identification, benefits, etc.
- » Medical Prescription Assistance helps uninsured clients access prescriptions
- » Crime Victim's Assistance Program provides support and resources for crime victims
- » Transportation Assistance provides bus tokens and gas certificates to help clients access benefits and seek employment
- » The Sargent Fund helps low-income clients, whose needs fall outside of other grants, paying for special medical equipment, car repairs, etc.
- » Gift of Hearing Program provides those in need of low- or no-cost hearing aids

### ENRICHMENT PROGRAMS

- » Ready, Set, School! Program provides school supplies and clothing to children each fall
- » Mother's Day Program provides gifts and food for single mothers

- » Holiday Programs provide holiday gift and food baskets for low-income families and seniors

### OTHER ASSISTANCE

- » Clothing Banks provides no-cost clothing
- » Recreation Passes for clients to access community recreational programs
- » Gift of Sight provides low- to no- cost glasses
- » Case Management and Follow-up for clients in IFCS programs

## Report of Service

The 2016-17 year was a very busy for Integrated Family Community Services with many new clients and a large amount of services going to our community.

### 15,225 low-income individuals were served during fiscal year 2016-2017

#### NEW CLIENTS

- » 407 new low-income families, individuals, and senior citizens came to IFCS for assistance

#### HOMELESS PREVENTION

- » \$125,377 was spent to assist 419 individuals to prevent homelessness

#### HUNGER PREVENTION

- » 6,338 individuals received 133,098 meals. Each individual received enough food for three meals for five days. An estimated dollar amount of \$887,320.

#### FINANCIAL ASSISTANCE

- » \$1,000 was spent to assist 210 individuals with medical prescriptions, transportation, birth certificates, hearing aids, and Sargent Fund
- » \$52,410 was spent to assist 197 crime victim individuals

#### ENRICHMENT PROGRAMS

- » 390 children received new clothes and school supplies through IFCS Ready, Set, School! Program
- » 374 children received backpacks and school supplies
- » 2,625 individuals benefited from IFCS' Holiday Programs
- » 66 children received toys through IFCS' Holiday Program

- » 380 individuals benefited from receiving Mother's Day Baskets

#### OTHER ASSISTANCE

- » 1,100 individuals received clothing, totaling \$42,920
- » 967 individuals benefited from receiving recreation passes from South Suburban and Englewood Recreation, distributed through IFCS
- » 5,163 referrals were made to other organizations

#### VOLUNTEERS

- » 1,475 volunteers gave 5,748 volunteer hours to IFCS
